ITEM 1. CALL TO ORDER. Mayor Agenbroad called the Springboro, Ohio City Council Work Session to order on Thursday, September 15, 2022 at 6:00 PM in Council Chambers at the Springboro Municipal Building, 320 W. Central Avenue, Springboro, Ohio.

ITEM 2. ATTENDANCE. Council: Mr. Harding were absent. **Staff:** Mr. Pozzuto, Mr. Shackelford, Mr. McDonald and Ms. Martin were present. Police Chief Jeff Kruithoff and Finance Director Jonathan Hudson were also present.

ITEM 3. LEGISLATIVE AGENDA. – Review legislative items slated for September 15.

- 1) **ORDINANCE: THIRD READING.** AN ORDINANCE EXPANDING A DESIGNATED OUTDOOR REFRESHMENT AREA TO INCLUDE ADDITIONAL PROPERTY WITHIN THE MUNICIPAL CORPORATION AND ESTABLISHING REQUIREMENTS TO ENSURE PUBLIC HEALTH AND SAFETY WITHIN SUCH AREA

- 2) **ORDINANCE: SECOND READING.** AN ORDINANCE AMENDING CHAPTER 1276, SOLAR ENERGY SYSTEMS, OF THE PLANNING & ZONING CODE.

Staff requested that Council waive the third reading and proceed with adoption of this ordinance, as amended, at tonight's Regular Meeting.

Mr. Pozzuto explained that the amendment simply states that applicants must submit a preliminary plan to the City Planner for review prior to approval for construction.

ITEM 4. CITY MANAGER. – Issues/Reports.

Mr. Pozzuto reported on the following items:

Fiber to Home Project: *Point Broadband has nearly wrapped up their fiber installation, but Alta Fiber will begin their installation project, which should take approximately 8-12 months. Once Alta Fiber's project is complete, the City will have three internet service providers (ISPs) for people to choose from. The choice of ISPs is already creating market competition.*

Mr. Brunner confirmed that Alta Fiber would take 8-12 months to install and asked if they would be installing additional boxes.

Mr. Pozzuto replied yes, and explained that the City cannot require them to use the same boxes as their competitors; each company has their own boxes. Mr. Pozzuto further explained that the boxes have to be spaced approximately 300 to 400 feet apart; therefore, some homes may have one box or two boxes or no boxes in the right-of-way. The City continues to publicize information regarding the fiber project through social media, newsletters, etc.

Mr. Hanson asked if any thought has been put into fiber providers potentially continuing to come into the City and installing boxes everywhere.

Mr. Pozzuto commented that he does not anticipate another provider coming into Springboro; the community would be over saturated. It could happen, but realistically it is not going to happen. It is rare to have three providers in a community let alone four, five or six. Mr. Pozzuto further commented that a business provider might come into the community, but they would market strictly to businesses addresses, not residential neighborhoods.

Blood Drive, September 2: The City hosted a Blood Drive on Friday, September 2 in the Community Room, which was spearheaded by Police Officer Dustin Christian and Administrative Assistant Sharon Rottert, who coordinated the event. Fifty people donated blood in support of Clearcreek Township Officer Eric Ney, who was critically injured by a gunshot wound on July 12. People from agencies all over the county participated in the blood drive.

Golf Course General Manager Tom West Named the Southwest Ohio Merchandiser of the Year: Mr. West received this award for his merchandising management of the Heatherwoode Golf Course pro shop.

Kacie Jane Park Closes for the Season: Kacie Jane Park will close for the season this Sunday, September 18. Monday, September 19 will be Doggie Day at the splash pad.

Annual Street Paving Program: This program was originally scheduled to begin in September, but has been pushed back to October due to supply chain delays.

Patriot Golf Outing: This golf outing will take place tomorrow, September 16 at Heatherwoode Golf Course with a shotgun start at 10:00 AM. The City and the Military Order of the Purple Heart are among the sponsors of this event. This golf outing is associated with Folds of Honor and all proceeds from the event will support the Folds of Honor and first responders. They plan to hold this golf outing at Heatherwoode Golf Course every year.

- 1) **ORDINANCE O-22-34: THIRD READING.** AN ORDINANCE EXPANDING A DESIGNATED OUTDOOR REFRESHMENT AREA TO INCLUDE ADDITIONAL PROPERTY WITHIN THE MUNICIPAL CORPORATION AND ESTABLISHING REQUIREMENTS TO ENSURE PUBLIC HEALTH AND SAFETY WITHIN SUCH AREA, was read by the Clerk of Council. Mr. Shackelford's comments are summarized as follows:

This is the third reading of an ordinance expanding Springboro's Designated Outdoor Refreshment Area (DORA) to include additional property within the City. This ordinance was the subject of a Public Hearing and First Reading at the August 18, 2022 Council Meeting, and would extend the existing DORA, located at Wright Station, to the downtown Historic District, specifically from SR73 along S. Main Street to Springboro United Church of Christ on the west side of the street and Midwestern Wealth Management on the east side of the street.

- 2) **ORDINANCE O-22-35: SECOND READING.** AN ORDINANCE AMENDING CHAPTER 1276, SOLAR ENERGY SYSTEMS, OF THE PLANNING & ZONING CODE, was read by the Clerk of Council. Mr. Pozzuto's comments are summarized as follows:

This is the first reading of an ordinance amending Chapter 1276, Solar Energy Systems, of the City's Planning & Zoning Code. This ordinance was the subject of a Public Hearing and First Reading at the September 1, 2022 Council Meeting. The City's current solar energy regulations date back to 2012 and are now among the most restrictive in the area. These amendments will continue to uphold aesthetic standards, but also provide more flexible regulations to allow people to take advantage of the new solar technology to reduce their energy bills. These amendments would also shorten the review process for solar energy projects and eliminate the fee for plan review.

- 3) ORDINANCE O-22-36: FIRST READING.** AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL APPROPRIATION OF MONIES; THEREBY AMENDING ANNUAL APPROPRIATION ORDINANCE NO. O-21-01 OF THE CITY OF SPRINGBORO, OHIO PASSED BY THE CITY COUNCIL ON DECEMBER 16, 2021 FOR THE YEAR 2022; AND DECLARING AN EMERGENCY, was read by the Clerk of Council. Mr. Hudson's comments are summarized as follows:

This is the first reading of an ordinance authorizing supplemental appropriations increasing the total 2022 appropriations by \$1,850,000. This supplemental covers costs associated with the Residential Grant Program (Home Improvement Grant Program) and fund transfers for new debt the City issued earlier this year. The debt transfer from one fund to another is accounted for twice, but represents only one expenditure.

Mayor Agenbroad presented the item for questions/comments of Council.

Ms. Ridd thanked staff for getting that funding back into the budget. Ms. Ridd further commented that she thinks it is a really important program for the community.

This resolution accepts the amounts and rates as determined by the Warren Budget Commission and authorizes the necessary tax levies and certifies them to the County Auditor for Warren County. Legislative Items 4 and 5 are annual legislation that certifies the City's property tax rates with Montgomery County and Warren County, and there is no change from prior years. Springboro has the lowest municipal property tax rates in the south suburbs, and there has been no change for approximately 30 years. Again, this is a routine annual recertification of the tax levies with the two counties.

TO COMPLETE THE WASTEWATER TREATMENT PLANT DIGESTER BLOWER REPLACEMENT PROJECT, was read by the Clerk of Council. Mr. Pozzuto's comments are summarized as follows:

This resolution authorizes a contract with J. L. Kuck General Contractors, Inc. to complete the Wastewater Treatment Plant Digester Blower Replacement Project. This project consists of replacing two digester blowers at the Waste Water Treatment Plant that have met their life expectancy and need to be replaced. The City received two bids for this project with the lowest bid received from J.L. Kuck General Contractors in the amount of \$493,559.99. The engineer's estimate for this project was \$780,000. Despite the current economic conditions, the City continues to receive decent pricing on bids.

This resolution authorizes an agreement with ODOT to develop, plan, construct and install and maintain the gateway monument/landscape project at the interchange of I-75 & SR73. This legislation is required by ODOT for any ODOT related project. This is the gateway aesthetic project that the City is partnering with the City of Franklin to complete at the I-75/SR73 interchange. This legislation basically states that the City will maintain any landscape, hardscape, monuments, lighting, etc. when the project is complete. This project will be constructed in two phases beginning with some tree and shrub plantings in a month or two. Following this first phase, ODOT will construct their safety project on SR73, which involves widening the roadway under the bridge and adding some turn lanes. Following the roadway construction, the aesthetic project will resume in 2024 with the installation of lighting, monuments and other aspects of the project.
