## From the Office of Mayor and City Council

Thank you to everyone who participated in the celebration of Springboro's Bicentennial over the Fourth of July weekend; we have so much to celebrate! We have inherited a great city from our founders and are fortunate to have such a long history of community-minded citizens who embody the spirit of Springboro, like so many of you. Many more thanks to the members of Boro200, an independent committee of Springboro residents who planned and organized our Bicentennial Celebration; and to the many volunteers, businesses and organizations for making it a truly memorable event for the entire community. Congratulations Springboro on 200 years of history and success!



Our summer began with a weekend-long celebration of our bicentennial at North Park and continued with a great season of concerts. This year's "Concerts in the Park" series consisted of eight free concerts on Tuesday and Friday nights in July. This is the second year of our Friday night concerts, and with the exception of a few rainy evenings, we had an excellent turnout. We would like to thank the Springboro Wee Panthers Football Organization for volunteering at the concerts on Fridays, which enabled them to raise about \$1,900 for their organization. The annual concert series is made possible by the sponsorship and efforts of our Park Board and city staff and the support of our community. Playhouse South returned to Springboro in August to present six performances of "The Music Man," free to audiences during this summer's Theatre Under the Stars production at North Park. We thank everyone involved



in making our parks a great destination and such a highly rated amenity.

City officials frequently attend groundbreakings, ribbon cuttings and grand openings in the city as business continues to develop and grow. Pace and quality of development clearly demonstrates that Springboro is a very desirable place to do business and we have seen some promising economic growth over the past year. Since January, we have joined the Springboro Chamber of Commerce in welcoming a number of new businesses to the community with a groundbreaking for a new medical center at the corner of Village Park and SR741 and ribbon cuttings for a new commercial business, the first in The Ascent office development facing I-75, and new retail services opening downtown. We also look forward to a major business expansion in South Tech Business Park also adjacent to I-75 and the completion of the assisted living facility under construction on SR73. We wish our entire business community continued success and prosperity!

Earlier this year, City Council adopted a new Planning and Zoning Code and Zoning Map for Springboro. A team of staff and committee members worked with a community planning consultant over two years to update the existing code to modern standards and current planning and zoning practices. The new Planning and Zoning Code replaces a code that dated to 1976, and is designed to be more user-friendly by incorporating graphics, tables and extensive cross-references to improve readability. The newly revised code integrates Springboro's Land Use Plan and addresses new technologies and development

practices such as solar and wind energy systems. The revised Zoning Map eliminates township zoning within our corporate boundaries and reclassifies business zoning districts according to Land Use Plan recommendations. Springboro's new Planning and Zoning Code is a much more viable tool in providing for and regulating private development and managing growth in the community. Thank you for the tremendous effort made by everyone who contributed to this project.

This fall City Council will review the city's 5-Year Capital Improvement Program. Staff will be evaluating capital needs for the next five years such as street and park improvements, water and sewer infrastructure improvements and equipment for operations and services including police, building and zoning administration and street maintenance (annual leaf collection, snow removal, water main and roadway repairs and maintenance of public properties), and will make a recommendation to City Council in mid-October. Work is progressing on current capital projects including the SR741/SR73 intersection improvements under the management of the Warren County Transportation Improvement District (TID). This project will help meet the growth in roadway transportation needs in the community by improving traffic flow and safety at Springboro's main intersection. The TID is working on right-of-way acquisition with property owners impacted by this project and more than \$3 million is anticipated from grants to help fund these improvements. Also, the design for improvements to the intersection of Greenwood Lane and Sharts Road on SR73 is complete and the project will be bid later this year for improvements to help relieve traffic problems for businesses and their clients in the I-75 area.

Capital improvements completed in 2015 include the resurfacing of West Central Avenue (SR73). We sincerely thank ODOT and the contractor for completing this job with minimal traffic interference by performing a majority of the construction work overnight. Our second SPARC and Go building at 510 N. Main Street is nearly finished, which will serve as a way station for bicyclists and pedestrians along N. Main Street in Springboro and will be equipped with restrooms, vending for bicycle repairs, water, etc. and a covered patio to rest and recharge on our local bikeway. The City also replaced a picnic shelter on the west side of Community Park, which is outfitted with solar panels to power the shelter. This project was funded in part by a donation from the Springboro Optimist Club, who donated

\$9,000 toward the construction of the shelter and was recognized for their contribution at the dedication ceremony in mid-September. In addition, this year marks the initiation of our neighborhood sustainability plan with extensive concrete and water main replacement work within the Tamarack Hills and Royal Oaks Subdivisions. With City Council's approval, staff proposed and budgeted for a sustainability plan last year. The objective is to provide the community with a long-term plan to identify neighborhoods and commercial areas and prioritize needs to improve infrastructure, roadways and aesthetics in order to preserve the overall health, safety and appearance of our community.

Election Day is Tuesday, November 3 and a number of local government officials will be elected in area communities including Springboro; polls open at 6:30 a.m. and close at 7:30 p.m. Three Springboro City Council seats will be on the ballot this November. Current Mayor John Agenbroad is unopposed and three candidates have been certified to run for two at-large seats. **The deadline to register to vote in the upcoming election is October 5.** Please notify the Warren County Board of Elections of any changes to your identification; your current name and address must be listed at your polling site and a valid ID is required to vote. “Bicentennial Christmas” is the theme of this year’s “Christmas in Historic Springboro” festival, the weekend of November 20-22. This annual tradition begins with a tree lighting ceremony on Friday evening at 6:45 p.m. and is highlighted by a parade on South Main Street in our beautiful historic district at Noon on Saturday. The festival is a great opportunity to stroll through downtown Springboro and explore the local shops and businesses, enjoy horse-drawn wagon rides, children’s activities and plenty of food and entertainment. The festival is managed by the Springboro Christmas Festival Committee and supported by the sponsorship of Springboro area businesses and organizations. ## Leaf Collection

It's hard to believe, but it is that time of year again when the leaves will be falling off the trees! Details of the 2015 Leaf Collection Program are below:

**Collection Schedule** – Leaves will be collected from Monday, October 5 through Friday, December 11 .

**Areas To Be Collected** – Leaves will be collected from all areas of the City. Crews will collect leaves from each area a minimum of FOUR TIMES after the start of collection. (*Please see map on opposite page to determine dates your street/area will be visited during the collection program.*) If your leaves don't happen to be falling in October when crews visit the first time – don't worry, crews will be back a minimum of three more times well into December.

**What We Need You To Do To Help** – To keep the leaf collection on schedule and to help keep costs down, please adhere to the following:

- **DO NOT rake anything except leaves out to the curb for collection.** Branches, sticks and other waste clog the machinery and can potentially damage the leaf vacuum.
- Rake your leaves to the curb or tree lawn, but not into the street where they will block traffic.
- Please have your leaves raked out to the curb at least two (2) days before crews are scheduled to arrive (*Again, see leaf collection map.*) Depending on Mother Nature, equipment problems and the volume of

leaves, the crews may be as much as two days early or two days late.

- Do not bag your leaves and leave them out for the City's collection



crews. Any bagged leaves will be by-passed. Leaves must be raked out to the tree lawn or curb all by themselves for ease of pick up by the leaf vacuums. Please rake leaves to as **close to the curb as possible**. Bagged leaves will be left for Waste Management to pick up as part of their yard waste collection.

- **Do not park vehicles within 20 feet of the leaf piles.** Leaves must be accessible to the trucks and the leaf vacuum. If leaves are not accessible, **they will be bypassed** – we do not want to risk damaging the leaf vacuum or your vehicles.



## 2016 Charter Review Commission



It's hard to believe that eight years have passed since our last Charter Review, but the city will begin this process once again in 2016! Our Charter provides for the review process, which begins with the appointment of nine (9) citizens to form a Charter Review Commission.

Springboro City Council is seeking interested citizens to serve on the Charter Review Commission for 2016. Applicants must be a resident of the City and a registered voter. Charter Review Commission appointees will serve for one year and will meet monthly to fulfill their duties.

The 2016 Charter Review Commission will officially begin the review process in January by conducting a series of meetings to review the existing Charter and make any recommendations for revisions. The Commission must submit a formal report to City Council no later than July 1, 2016. City Council will consider the commission's recommendation and authorize the submission of any Charter amendments to the voters for approval at the next general election on November 8, 2016.

## Parks Update



### Community Park

The new Optimist Club Shelter was erected this summer, replacing a very old metal roof shelter at the western end of the park. The new shelter includes solar panels to power the outlets and new picnic tables. Thank you to the Optimist Club of Springboro who donated \$9,000 towards the project.

### Clearcreek Park

An additional section of the walking path around the outer border of the park is scheduled to be put in place in the Fall. When the paved path is complete, the entire distance should measure about 1.5 miles!

### Hazel Woods Park

Design work continues on the bridge across Clear Creek to access the park. Once the design is approved and the bridge construction is out to bid, work can begin on developing the LAX and Soccer fields as well as the Dog Park that is planned for our newest park.

In future years, the City plans to continue to observe Beggar's Night on October 31st, no matter on what day of the week it might happen to fall!




## Moody's Upgrades City Financial Rating Once Again

Moody's Investors Service has recently upgraded the City of Springboro's sewer revenue bonds to an Aa2.

The Aa2 reflects Springboro's very strong liquidity resulting from a stable and diverse customer base, satisfactory legal covenants that include a fully funded debt service reserve fund, and manageable debt ratio.

Aa2 is the second highest credit rating on the Moody's scale, and is deemed to be of high quality and have a very low credit risk.

## The Landing of Springboro



It seems EVERYONE in Springboro had asked at one time or another – “What is that large complex being built across the street from the City Building?” It is the **Landing of Springboro**, which is a new assisted living community for active older adults in the Greater Cincinnati and Dayton area.

Located at 355 West Central Avenue and opening in November, The Landing will provide 24-hour assistance with day-to-day care needs, as well as memory care for seniors living with Alzheimer’s or other types of dementia. The Landing of Springboro will offer 86 apartments that are both Independent Living as well as Assisted Living and 25 apartments in their memory care neighborhood.

Amenities include multiple dining venues, a salon and barber shop, a wellness center for physical therapy, and common spaces such as a library, media room, patio and courtyard. Residents can enjoy dining with table service, engaging events and activities, and regular outings to local shops, restaurants and attractions.

## PUBLIC WORKS PROJECTS



### Sharts Road and Greenwood Lane Intersection Improvements

An additional left turn lane is being added for Sharts Road and Greenwood Lane at the intersection of State Route 73. Upon completion, Sharts Road will have dual left turn lanes onto SR 73. Traffic signal improvements are also being made, upgrading the existing strain poles to mast arms. The design is complete. Project will be sold this fall with construction to begin in the spring of 2016.



### Royal Oaks Subdivision Concrete Improvements

Deteriorating concrete curbs, sidewalks, and driveway aprons are being replaced in the Royal Oaks subdivision on the following streets: Royal Drive, Oak Drive, Hemlock Court, West Market Street, West Factory Road, Carey Drive, School Drive, and Dugan Place. This work is being completed in conjunction with the City's Sustainability Initiative. The contract has been awarded to R.A. Miller. Work began in early August.



### Water Main Improvements – Bramble Bush, West Market Street, Carey Drive

Design is complete on replacing an existing 6" water main on Bramble Bush and Carey Drive with new 8" water mains, as well as replacing the existing 8" water main on West Market Street. There have been many water main breaks in these areas, and the mains require replacement. The new 8" water main will be installed the entire length of each road. Project will be sold this fall with construction to begin in spring of 2016.



### Tahlequah Trail Storm Sewer Improvements

Improvements are to be made on Tahlequah Trail from SR 73 to Edwards Drive. This project will include the installation of curb and gutter and storm sewers. The project is currently being designed with construction to be in the late fall of 2015.



## What To Do When Your Trash Is Missed?

Occasionally on trash day, Waste Management (WM) will miss a house or entire street and residents will call in to the City to let us know. We appreciate knowing so we can alert Waste Management! But the residents also ask, "What should I do with the trash now?" If WM does miss your house, simply leave the trash out as they should be back to collect it the very next day.

The City is aware that this happens sometimes, and we attempt to stay on top of the issue to ensure proper pick up. Sometimes though, there are reasons why Waste Management misses some of the pickups.

On heavy trash days, sometimes the drivers just aren't able to get around to their entire route. Due to federal law, the drivers are only permitted to be driving in their trucks a certain number of hours per day, and this includes the time it takes to get to Springboro from their home base and back. So, if it is taking them a little longer to collect all the trash because there is more of it, then they may not be able to finish the entire route due to their compliance with the law.

Another issue that arises occasionally is there may be a replacement driver on the route. As may happen with your job, when you take vacation, you may have a "replacement" that comes in to assist? The same thing happens with trash collection. And of course, the replacement doesn't know the route as well as the regular driver, so they may miss houses or streets.

Finally, while we appreciate the phone calls when trash is missed, because it helps us identify areas Waste Management needs to return to, you don't need to call if it is 1:00pm and the trash is usually picked up at noon. Trash pickup day is scheduled for the entire day Tuesday, so if they aren't there by noon, they will probably get there before the end of the day. If they haven't been there by evening, please feel free to call us at (937) 748-4343.

### Winter Time Tips – Stormwater Management Tips

#### Did you know?

Excess salt and other deicing chemicals can harm aquatic life in our streams and impact drinking water supplies.

This winter you can help by following these environmentally friendly snow removal practices:

- Shovel snow before it turns to ice to limit the need for deicing chemicals like rock salt.
- Shovel snow onto non-paved surfaces such as landscaped and/or grassy areas. As the snow melts it will soak into the ground rather than flow directly into a nearby storm drain or stream.
- Sand and sawdust can be used as an environmentally friendly alternative to commonly used salt products. Cracked corn has been suggested as an alternative because animals can eat it before it gets washed into the storm sewers in the spring.
- After snowmelt, sweep up residues, including sand, to prevent it from washing into the storm drains and streams.
- Using the old fashioned approach of a shovel means eliminating ice and snow without harmful chemicals and it also provides the added benefit of physical exercise.
