

Citizen Attitude and Public Opinion Survey Results


During the spring, the City, in conjunction with the Center for Public Management and Regional Affairs (CPMRA) at Miami University, conducted a Citizen Attitude and Public Opinion Survey to gauge the level of satisfaction our residents have with city services. This survey helped to show what citizens think we do well, don't do well and what needs to be improved upon. This was a follow up to the surveys conducted in 2008, 2011 and 2014.

Thank you to the 385 of 1,215 randomly selected households that responded to the survey. That comprises a response rate of 32%, which is down slightly from previous surveys, but is still an excellent response to a survey of this type. In 2017, 97% of respondents said they were either "very satisfied" or "satisfied" with living in Springboro! That has increased from 87% in 2008.

Other results and things that the City seems to do well:

- 92% rated Springboro either Excellent or Good as a place to raise a family.
- 85% were either Very Satisfied or Satisfied with Police services (up from 75% in 2014).

SPRINGBORO VETERANS MEMORIAL A dedication ceremony for Springboro's new Veterans Memorial is planned for Veterans Day, Saturday, November 11 at 11am. We have so many people to thank for making this project a reality including our City Manager Chris Thompson and Assistant City Manager Chris Pozzuto for initiating this project and seeing it through from start to finish. The new memorial located at Gardner Park on N. Main Street is designed to represent all five branches of service through detailed military imagery. A paver walkway leads visitors to the central monument of the memorial, which is surrounded by granite walls and a grove of memorial trees. We look forward to gathering with the community for this very special event in the history of our city, and invite you to share in the dedication of this beautiful tribute to the service and sacrifice of our veterans.

BOARD & COMMISSION NEWS Bicycle & Pedestrian Advisory Committee (BPAC) Chairman John Davies congratulated the City on being designated a Bicycle Friendly Community at a presentation in July. Springboro was awarded the Bicycle Friendly Community designation by The League of American Bicyclists for outstanding efforts to encourage bicycling in our community. The program recognizes communities for their work in making their communities more viable places to live, work and play by providing bicycle infrastructure and programs for health, fun and transportation.

Springboro is one of only 17 communities in Ohio to be so recognized for efforts such as Springboro's police department enforcement and education programs, the construction of two bike hubs (SPARC and Gos), the installation

of more than 10 miles of bike lanes and shared lanes and events like "Bike the Boro" and our Bike Friendly Business Program. The work of our BPAC, and Springboro's Bicycle & Pedestrian Plan, has set an example for other communities to follow in their efforts to accommodate cycling and pedestrian transportation. We thank our current and past BPAC Members for helping to make bicycling and walking such an integral part of our community over the past 8 years.



The City of Springboro receives an Ohio Environmental Protection Agency award for exceptional implementation of its source water protection program.

CITY RECEIVES EPA AWARD The Ohio Environmental Protection Agency presented an award to the City this year for exceptional implementation of its source water protection program. Springboro was recognized by the EPA for exceptional efforts to protect the source of our drinking water. The City's drinking water is supplied by six ground water wells located along the Great Miami River near Chautauqua. Springboro is one of 165 community ground water systems in southwestern Ohio and the Ohio EPA has determined that less than half of these communities are actively protecting or implementing any efforts to protect their source of drinking water from contamination. Springboro has been recognized as 1 of 9 communities doing an exceptional job of protecting the source of our drinking water. EPA representatives recognized Springboro Development Director Elmer Dudas, Water/Wastewater Operations Manager Terry Morris of Veolia Water and Paul Stork of AMEC Foster Wheeler for having contributed to this achievement and for working to protect our drinking water.

ELECTION DAY Tuesday, November 7th is Election Day and polls are open 6:30 a.m. to 7:30 p.m. A number of local government officials will be elected in area communities this November including Springboro, which has four city council seats on the ballot. The

Citizen Attitude and Public Opinion Survey Results

- The public seems to think the City is doing better with snow removal, with 88% being satisfied.
- 86% either Strongly Agree or Agree that they are satisfied with the Springboro parks system. The highest response of satisfaction was for the paved walking trails that have been added to the parks.
- 72% of respondents stated they get most of their information about the City and City activities from the publication you are reading right now – the *City Notes* newsletter!

Things that need to be improved:

- Pothole Repair – 18% of respondents stated it has gotten worse since 2014. This was an area of concern in past surveys as well. Recently, the City purchased a new machine to help with pot hole repairs and more effort and resources will be concentrated on this area of concern.
- Street Name Signs – 4% of respondents stated it has declined since 2014. This is an area that the City has focused on the past few years with the new blue “City logo” signs that we have begun placing in different neighborhoods. We will continue to add new signs to all remaining neighborhoods (without their own specific street signage) as time allows.
- Property Maintenance control concerning overgrown weeds.

Overall, the City scored well in most categories, but as always, there is room for improvement with everything we do. City Staff continually analyzes all processes in the City to ensure we are providing the best services possible. Thank you again to everyone who participated in the survey.

Leaf Collection

It's hard to believe, but it is that time of year again when the leaves will be falling off the trees! Details of the 2017 Leaf Collection Program are below:

Collection Schedule – Leaves will be collected from Monday, October 16 through Friday, December 6.

Areas To Be Collected – Leaves will be collected from all areas of the City. Crews will collect leaves from each area a minimum of FOUR TIMES after the start of collection. (*Please see map on opposite page to determine dates your street/area will be visited during the collection program.*) If your leaves don't happen to be falling in October when crews visit the first time – don't worry, crews will be back a minimum of three more times well into December.

What We Need You To Do To Help – To keep the leaf collection on schedule and to help keep costs down, please adhere to the following:

- **DO NOT rake anything except leaves out to the curb for collection.** Branches, sticks and other waste clog the machinery and can potentially damage the leaf vacuum.
- Rake your leaves to the curb or tree lawn, but not into the street where they will block traffic.
- Please have your leaves raked out to the curb at least two (2) days before crews are scheduled to arrive (*Again, see leaf collection map.*) Depending on Mother Nature, equipment problems and the volume of

leaves, the crews may be as much as two days early or two days late.

- Do not bag your leaves and leave them out for the City's collection



crews. Any bagged leaves will be by-passed. Leaves must be raked out to the tree lawn or curb all by themselves for ease of pick up by the leaf vacuums. Please rake leaves to as **close to the curb as possible**. Bagged leaves will be left for Waste Management to pick up as part of their yard waste collection.


- **Do not park vehicles within 20 feet of the leaf piles.** Leaves must be accessible to the trucks and the leaf vacuum. If leaves are not accessible, **they will be bypassed** – we do not want to risk damaging the leaf vacuum or your vehicles.



Heatherwoode is open to the public and always has been. Come out and see everything Heatherwoode has to offer - you will be hard pressed to find anything better.





Parks Update



Hazel Woods Park

Hazel Woods, which is 108 acres, will be developed in three phases over the next 3 years. The first phase, which is the easternmost portion of the park (to the left if you are standing on the bridge), will include a two-acre dog park with a large and small dog area and two LAX/Soccer fields. The second phase (middle area of park) will include a concession stand/restroom facility, playground and 4-6 LAX/Soccer playing fields. The final phase (western portion) will include and additional 4-6 LAX/Soccer playing fields.

Hazel Woods will also include a paved walking trail, nature areas by the creek and plenty of parking. Plans are to make the park the LAX/Soccer facility and then Clearcreek Park will become the baseball and pee wee football facility.

The earthwork for Phase I has been completed and the dog park development is underway as this newsletter is being printed. More information will be provided regarding the dedication of the dog park through the City's website, E-newsletter, Facebook and Twitter pages.

City Manager Christine Thompson Retiring as City Manager After 28-Year Career With City; Current Assistant City Manager Christopher Pozzuto Appointed as New City Manager

At the August 3, 2017 City Council meeting, City Manager **Christine A. Thompson** formally announced her retirement as City Manager on October 1, 2017 after 28 years of service to the City of Springboro. Ms. Thompson has many accomplishments during her tenure as City Manager, for the past 17 years, including the construction of a new City Building, the financing and construction of the Austin Road Interchange in conjunction with Miamisburg, Miami Township and the Montgomery County Transportation Improvement District (MCTID), the expansion of the water treatment and wastewater treatment plants to facilitate additional economic development within the City, doubling the amount of park and open space within the City, and a plethora of other accomplishments.

“Ms. Thompson has served the City with the vision and leadership that the City has needed for the past 17 years as City Manager,” stated Mayor John Agenbroad. “She has guided the City through a large residential and business growth period, and the City would not be where it is today without her leadership. The City Council and I wish her well in the next phase of her life, and we value all the hard work and accomplishments she has made as City Manager.”

Following Ms. Thompson’s retirement announcement, City Council voted unanimously to appoint current Assistant City Manager, **Christopher (Chris) J. Pozzuto**, as the next City Manager. The appointment is effective October 2, 2017.

Mr. Pozzuto has served Springboro as the Assistant City Manager, being first appointed in April, 2003. As the Assistant City Manager, Mr. Pozzuto has been responsible for leading all aspects of economic development in the City, as well as the Human Resources Director and Acting City Manager in the City Manager’s absence.

Mr. Pozzuto holds a Master’s of Public Administration (MPA) from The Ohio State University and a Bachelor’s of Arts (BA) in Political Science from University of Dayton. He is active on multiple boards and alliances; including serving the past three years as the Chairman of the Warren County Chamber Alliance, was the first President of the Warren County Small Business Development Alliance, and served as a Board Member of the Ohio City Management Association (OCMA).

About Mr. Pozzuto’s appointment, Mayor Agenbroad stated, “We are very excited that we have someone like Mr. Pozzuto who can step right in as City Manager to provide continuity and keep this City moving in a good direction. Under Ms. Thompson’s mentorship, Mr. Pozzuto knows the culture of the City, has lived here for the past 14 years and is very much ingrained in the City through his work, his family’s involvement within the community and his dedication to continue to make Springboro the best community within the State of Ohio.”

Protect Our Waterways

There are areas of our Great Miami River Watershed that are considered "impaired", meaning the water quality and/or habitat in the streams of these areas have been damaged by local pollutants and activities.

Two of these impairments are Organic Enrichment and Low Dissolved Oxygen.

Organic enrichment occurs when nutrient-rich materials such as **soil, leaves, sticks** and **grass clippings** from yard waste go down the storm drain and into a stream. It also occurs when we use too much **fertilizer** or apply it at the wrong time, such as just before a rain, and not allowing enough time for the fertilizer to be soaked up by the grass.

Low dissolved oxygen is the *result* of having too many nutrients in the stream. The yard waste uses the oxygen in the water in its decaying process. This takes the oxygen away from the fish and other stream life that need it to breathe. Also, aquatic plants such as algae soak up these excess nutrients and grow much larger than they naturally would. When these large mats of algae (nuisance growths) decay they consume too much of the oxygen from the stream. Some liquids that leak from vehicles and equipment deplete oxygen in the stream as well.

To protect our waterways from the common problems above, please consider the following:

1. Never pour or put anything down the storm drain
2. Always measure fertilizer carefully and follow application instructions
3. Apply fertilizer a couple of days before or after a rain
4. Seed bare soil areas of your yard to prevent erosion
5. Wash your car and lawn mowers in the grass
6. Compost yard waste or mulch and reuse as natural fertilizer
7. Keep your septic system properly maintained if you have one





Former IGA Plaza Update

Recently, the City Council authorized a contract with James Peresi Design Studio and Van Atta Engineering to develop a master plan for the 6.5 acre former IGA Plaza and the 4+/- acres of land the City owns on the northeast corner of the SR 73 / SR 741 Intersection. Over the next month, City staff will be working with Mr. Paresi to design a redevelopment plan for those properties. The City is also working with VisCap and Synergy Building Systems, who were selected as developers for the redevelopment project.

Part of the design process will include a public input session, tentatively scheduled for the week of October 16, in which the City will invite residents to a public charette to provide input as to what types of uses residents would like to see located at the intersection.

Trash / Recycling Delayed Due to Christmas and New Years Holidays

Due to the Christmas Holiday being on Monday, December 25, trash / recycling collection will be delayed one day to Wednesday, December 27. The same will hold true the week after. Due to the New Years Day Holiday being on Monday, January 1, trash / recycling collection will be delayed one day to Wednesday, January 3.

In addition, we know you haven't even thought about putting up your Christmas tree yet, but when you take it down and put it out for collection, please remember that trees over five (5) feet tall, must be cut in half to allow for them to fit into the trash trucks.

Austin South - Springboro



During the September 7, City Council meeting, Mr. Larry Dillin a Principal with VisCap, unveiled plans for development of the 60 +/- acres of property on the south side of Austin Boulevard.

The development, being called **Austin South – Springboro**, is planned to be a mix of retail, office, multi-family, hotels and medical uses that will be developed unlike anything in the entire Dayton area. The plan calls for multi-story buildings with retail on the bottom floor and office/residential on the upper floors in many of the buildings. In addition, plans call for "public gathering spaces" in which seasonal programming will take place to provide entertainment and places for families to gather to enjoy the weather, eat ice cream or grab some dinner and take in the scenery.

This may sound a lot like the development on the north side of Austin Boulevard....it is and it isn't! While many of the uses might be similar in nature, Austin South – Springboro is designed to be a much more pedestrian and vehicle friendly development. The City has listened to our residents loud and clear about potential traffic issues with that development! In discussions with Mr. Dillin, City staff has stressed the need for better pedestrian and traffic circulation on the south side of Austin Boulevard. We believe we have accomplished that with this plan.

Mr. Dillin stated that plans are to begin development of the project in Spring 2018. Roadways and other public infrastructure will be constructed first and then users will begin to construct their buildings simultaneously, or shortly after the public infrastructure is in place. Additionally, the City will be designating that area as a Community Entertainment District, which should go a long way in attracting high quality restaurants to that development.

Hazel Woods Park Water Main

To provide water to the developing Hazel Woods Park, the City will be installing approximately 2, 400 feet of 8" water main. The project was bid on August 22, 2017. V&S Bowman, Inc. was the low bidder. Work is this project is anticipated to begin this fall.

2017 Street Resurfacing Project

The streets in this year's resurfacing program include: Artesian Court, Barley Court, Bentbrook Court, Cedar Hill Lane, Cold Springs Court, Huntley Court, Industry Lane, Kesling Drive, Lower Springboro Road (from the east Corp line to 1,900 feet west), Saddlebrook Court, Walnut Place and Woodstream Drive. Concrete repairs to the curbs, sidewalk and driveway aprons will also be completed on these streets as a part of this program. This project was awarded to R.A. Miller Construction Company. The project was anticipated to be complete by the end of September.

What To Do When Your Trash Is Missed?

Occasionally on trash day, Waste Management (WM) will miss a house or entire street and residents will call in to the City to let us know. We appreciate knowing so we can alert Waste Management! But the residents also ask, "What should I do with the trash now?" If WM does miss your house, simply leave the trash out as they should be back to collect it the very next day.

The City is aware that this happens sometimes, and we attempt to stay on top of the issue to ensure proper pick up. Sometimes though, there are reasons why Waste Management misses some of the pickups.

On heavy trash days, sometimes the drivers just aren't able to get around to their entire route. Due to federal law, the drivers are only permitted to be driving in their trucks a certain number of hours per day, and this includes the time it takes to get to Springboro from their home base and back. So, if it is taking them a little longer to collect all the trash because there is more of it, then they may not be able to finish the entire route due to their compliance with the law.

Another issue that arises occasionally is there may be a replacement driver on the route. As may happen with your job, when you take vacation, you may have a "replacement" that comes in to assist? The same thing happens with trash collection. And of course, the replacement doesn't know the route as well as the regular driver, so they may miss houses or streets.

Finally, while we appreciate the phone calls when trash is missed, because it helps us identify areas Waste Management needs to return to, you don't need to call if it is 1:00pm and the trash is usually picked up at noon. Trash pickup day is scheduled for the entire day Tuesday, so if they aren't there by noon, they will probably get there before the end of the day. If they haven't been there by evening, please feel free to call us at (937) 748-4343.



Permits for Building or Remodeling

Any resident wishing to remodel, build or add-on to any structure must first obtain a permit from the City of Springboro Building/Zoning Department. This would include the construction of decks, fences, patio covers, enclosures, accessory buildings, installation of irrigation systems, etc. Any remodeling to existing houses such as basements or any unfinished area in a home requires building plans to be filed with the City along with a building application. Applications may be obtained at 320 West Central Avenue or downloaded from the City of Springboro Web Page (www.ci.springboro.oh.us). **The new fee schedule went into effect January 1, 2017.**

Double fees are charged for work completed without a permit and some work may need to be removed and redone. It is very important to apply for the appropriate permit prior to work being started. Problems have developed when residents put their house on the market without proper inspection records on file with the Building Department.

Please contact the Building/Zoning Department at 748-9791 for any other information that you may require.

Winter Time Tips – Stormwater Management Tips

Did you know?

Excess salt and other deicing chemicals can harm aquatic life in our streams and impact drinking water supplies.

This winter you can help by following these environmentally friendly snow removal practices:

- Shovel snow before it turns to ice to limit the need for deicing chemicals like rock salt.
- Shovel snow onto non-paved surfaces such as landscaped and/or grassy areas. As the snow melts it will soak into the ground rather than flow directly into a nearby storm drain or stream.
- Sand and sawdust can be used as an environmentally friendly alternative to commonly used salt products. Cracked corn has been suggested as an alternative because animals can eat it before it gets washed into the storm sewers in the spring.
- After snowmelt, sweep up residues, including sand, to prevent it from washing into the storm drains and streams.
- Using the old fashioned approach of a shovel means eliminating ice and snow without harmful chemicals and it also provides the added benefit of physical exercise.
