Snow Plow Names Announced

The City held a snow plow naming contest for the 14 vehicles equipped for clearing snow on City streets. We received 162 submissions from 108 residents, with several plow names submitted multiple times. Each truck will have its new name on both the passenger and driver's side doors. All winning submitters will be contacted and recognized with a Springboro goodie bag. Look for these newly named snow plows on your street come snowfall!



Leaf Collection Starts Soon

The Service Department is gearing up for our annual leaf pickup service. **Early pickup will be offered Oct. 16, 17, 23 or 24**—depending on your area. To keep leaf collection on schedule and help keep costs down, please follow these guidelines:

- **Rake your leaves to the curb or tree lawn**, not into the street where they will block traffic.
- **Place your leaves at the curb at least two days before crews are scheduled to arrive.** Depending on Mother Nature, equipment problems and volume of leaves, crews may run up to two days early or two days late.
- **Do not rake anything except leaves to the curb for collection.** Branches, sticks and other waste clog the machinery and can potentially damage the leaf vacuum.
- **Do not bag your leaves for collection.** Leaves must be at the curb for ease of pick up by leaf vacuums. Bagged leaves will be left for Rumpke to pick up as part of their yard waste collection.
- **Do not park vehicles within 20 feet of leaf piles.** Leaves must be accessible to the trucks and the leaf vacuum. If leaves are not accessible, they will be bypassed – we do not want to risk damaging the leaf vacuum or your vehicles.

The income tax supports most of the services and equipment in our CIP including our annual street repaving program, water and sewer infrastructure, park development and maintenance along with funding snow plows and police vehicles. The last time Springboro voters had this issue before them was in 1988. The City of Springboro is committed to remaining fiscally responsible and transparent to our residents. 2023 Street Resurfacing Program Completed

The **2023 Street Resurfacing Program** is nearly completed. Funds from the City's Capital Improvement Plan (CIP) cover the cost of our Street Program. Streets resurfaced this year included: McDaniels Lane (from Pursley Lane to the west/south), Sweney Court, Bloose Court, West Pugh Drive, Lownes Court, Farr Drive (from Crockett Drive to the east), Crockett Drive (between West Pugh Drive and Farr Drive), Abbey Springs, Aspen Woods, Aberdeen Circle, Cedar Cove, Meadow Brook, Beckworth Way, Farmridge Road, Stapleton Way, Beckley Farm Way (between Beckworth Way and Stapleton Way), Cornish Court, Shockton Court and East Mill Street (from South Main Street to Beckworth Way/Village Drive). Work also included concrete repairs to curbs, sidewalk and driveway aprons.

Water Main Improvements

The new 8" water mains and water services upgrades on Fairway Drive and Clove Court were recently completed and these streets will be included for resurfacing in 2024. In addition, Fairway Drive at the intersection of West Central Avenue, was widened. Next year the City will replace the water main on Park Lane from Central to Renwood.

Mayor Agenbroad congratulates Miss Ohio Junior Preteen, Sommer Simon, who stopped by a City Council meeting. The fourth grade student at Five Points Elementary School has been volunteering around the community raising funds for several different organizations. She will compete for the national crown in November in Orlando.



City Keeps Eye on Budget

The **Springboro Budget is built upon conservative budgeting principles** and structured to provide efficient and quality resident-focused services. The budget reflects an emphasis on delivering core services, maintaining city infrastructure and providing safe and reliable public utilities. Key Capital Improvement investment areas include public safety, street resurfacing and infrastructure, recreation upgrades and public utility improvements. Sufficient funds have been allocated to ensure the City can provide the quality services that make Springboro the best place to live in Ohio.

Did YOU know

The City will spend \$4,074,750 for Street Improvements and Maintenance in 2023.

The city has committed \$13,752,000 for Capital Improvement projects for 2023. Major projects include:

Street Paving	\$2,125,000
North Park Upgrades	\$1,400,000

Income Tax Renewal FAQ: Issue 21

City Council has placed a 0.5% income tax renewal on the Nov. 7, 2023 ballot. This is the first time in 35 years that a tax issue will be on the ballot for the City of Springboro. The income tax supports our annual street repaving program, water and sewer infrastructure, park development and maintenance along with funding the purchase of snow plows and police vehicles. It will be Issue 21 on your ballot.

Q: Is this a new tax?

A: No, this is a renewal of the same earned income tax that has been in place since 1988.

Q: Does voting yes for this renewal raise my taxes?

A: Voting yes will NOT raise your taxes. This is a renewal of the 0.5% income tax passed in 1988.

Q: How is an earned income tax different from a regular income tax?

A: An earned income tax is a tax only on earned income. It does not tax social security, unemployment or pensions. **Retirees do not pay income tax on retirement income.**

Q: What does the 0.5% income tax renewal support?

A: The 0.5% income tax generates about \$5.6 million per year. The income tax supports the annual street repaving program, water and sewer infrastructure, park development and maintenance and the purchase of snow plows and police vehicles.

Q: What is Springboro's current income tax rate and how does it compare to surrounding cities?

A: Springboro's income tax rate is 1.5%-- lower than most communities of our size. For comparison, Centerville, West Carrollton, Miamisburg and Kettering are at 2.25%. Lebanon's income tax rate is 1.0% and Franklin's income tax rate is 2.0%.

Q: Will this income tax renewal go on forever?

A: No. The tax will expire in 20 years. Residents will have the opportunity to vote again at that time.

Q: What happens if this income tax renewal fails?

- A: If this income tax renewal fails, the City will need to eliminate \$5.6 million from our budget, which will affect the following:
- Street repaving: we currently repave approximately 20 to 25 streets each year
 - Park maintenance: we currently cut grass, weed eat, etc., two times per week in our parks, that maintenance service will be reduced to once every one to two weeks
 - Police vehicles and snow plow equipment: new purchases will be delayed, thereby affecting response times and how quickly we can clear streets during snow events

Q: What can I do to help?

A: Spread the word to your neighbors and friends that this renewal is critical to keeping Springboro the wonderful community it is and IT WILL NOT RAISE TAXES.

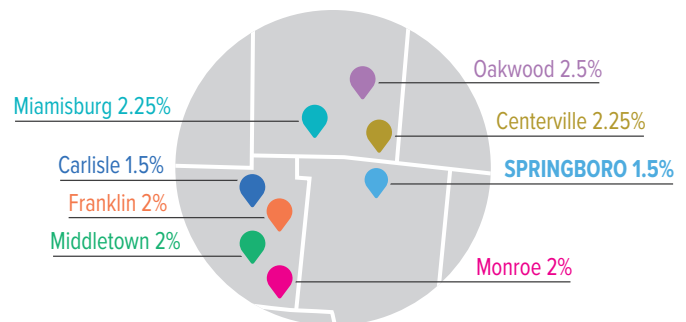

City Relying More on Income Tax, Springboro Property Tax Rate is Lowest in Region

Income Taxes

Income tax is the largest single source of revenue for the City. Generated from employee withholdings, taxes on the earnings of Springboro businesses and taxes paid by individuals—income tax comprises 80% of the General Fund. As the State continues to cut funding to cities, Springboro has increased its reliance on local income tax revenue.

The City of Springboro's income tax rate of 1.5% has been in place since 1988. The chart shows how Springboro compares to other cities in the region.



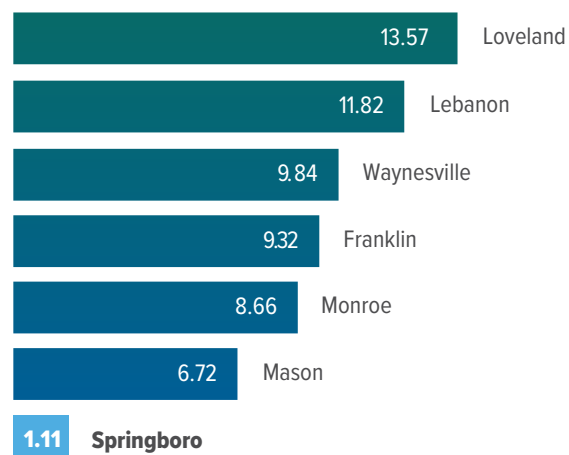
Property Taxes

Our municipal property tax rate—at 1.11 mills—is the third lowest in the state. Your Springboro municipal government realizes just over two cents from every property tax dollar collected to support City operations. The numbers below show the annual tax impact on the owner of a \$300,000 home in the City of Springboro, the school district, Warren County and Clearcreek Township along with several other smaller entities.

Did YOU know

The City of Springboro and Springboro City Schools are two separate entities, each with its own independent elected officials and budgets. The Springboro City School District is funded primarily with property taxes while the City of Springboro is funded primarily with income taxes.

Legislative Update

Your City Council meets monthly at 7 p.m. on the first and third Thursday in Council Chambers to pass legislation and authorize budgeted expenditures related to the management and operation of our City, and the health, safety and welfare of our citizens. Here are just a few agenda items recently approved by City Council.

- **Annual Tax Budget** – A projection of revenues and expenditures for the following year required to be filed annually with the Warren County Auditor's Office in order to receive the City's share of Local Government Funds and property tax revenue. Springboro's estimated share of Local Government Funds for 2024 is approximately \$250,000 and revenue from property tax will be approximately \$925,000.
- **An ordinance approving the record plan** for the South Tech Section Twenty Subdivision located **at the northwest corner of South Tech Boulevard and Industry Lane**. This record plan contains two lots on a total of 10 acres and is the site of the proposed InnoMark development.
- **An ordinance providing for the continuation of an existing 0.5% income tax** effective Jan. 1, 2024 and expiring Dec. 31, 2044. City Council authorized the proposed renewal of the City's 0.5% income tax to provide funds for general municipal operations and capital improvements, which will appear on the Nov. 7 election

ballot as Issue 21. If approved by the voters, Springboro's current income tax rate would continue at the same rate it has been for the past 35 years.

- **A resolution approving a lease agreement with Flock Group, Inc., for the continued leasing of the Flock Camera System.** The City has previously leased 18 Flock cameras on an annual leasing schedule. Under the new lease agreement, the City will lease the camera system for five years at a discounted rate and may terminate the lease at any time. The Flock cameras have proved invaluable to our Police Department in recovering stolen vehicles and identifying and apprehending various suspects from Springboro and other communities.
- **A resolution approving the Warren County Solid Waste Management Plan.** The Warren County Solid Waste Management District is required by the State of Ohio to update their Solid Waste Management Plan periodically, and the plan must be approved by political subdivisions within the district. The latest plan update was adopted by the district's policy committee on July 17, 2023. An approved plan allows our solid waste district to maintain compliance with Ohio EPA laws and goals to reduce waste by offering recycling and other waste reduction opportunities, and continue to offer local programs and services to Warren County residents and businesses.

City Remains Responsible Stewards of Tax Dollars

As we wrap up 2023, the City of Springboro's focus and budget remains on core services which includes:

- Resident-centered services
- Robust street-paving program
- Quality public safety services
- Improvements and maintenance of all 400 acres of public parks
- Continued updates to water and sewer infrastructure
- Businesses and new development support
- General community assistance

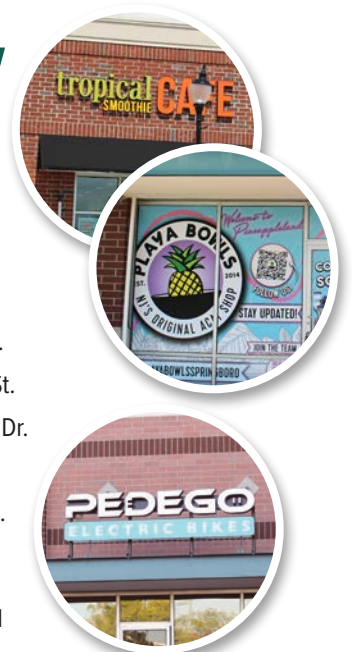

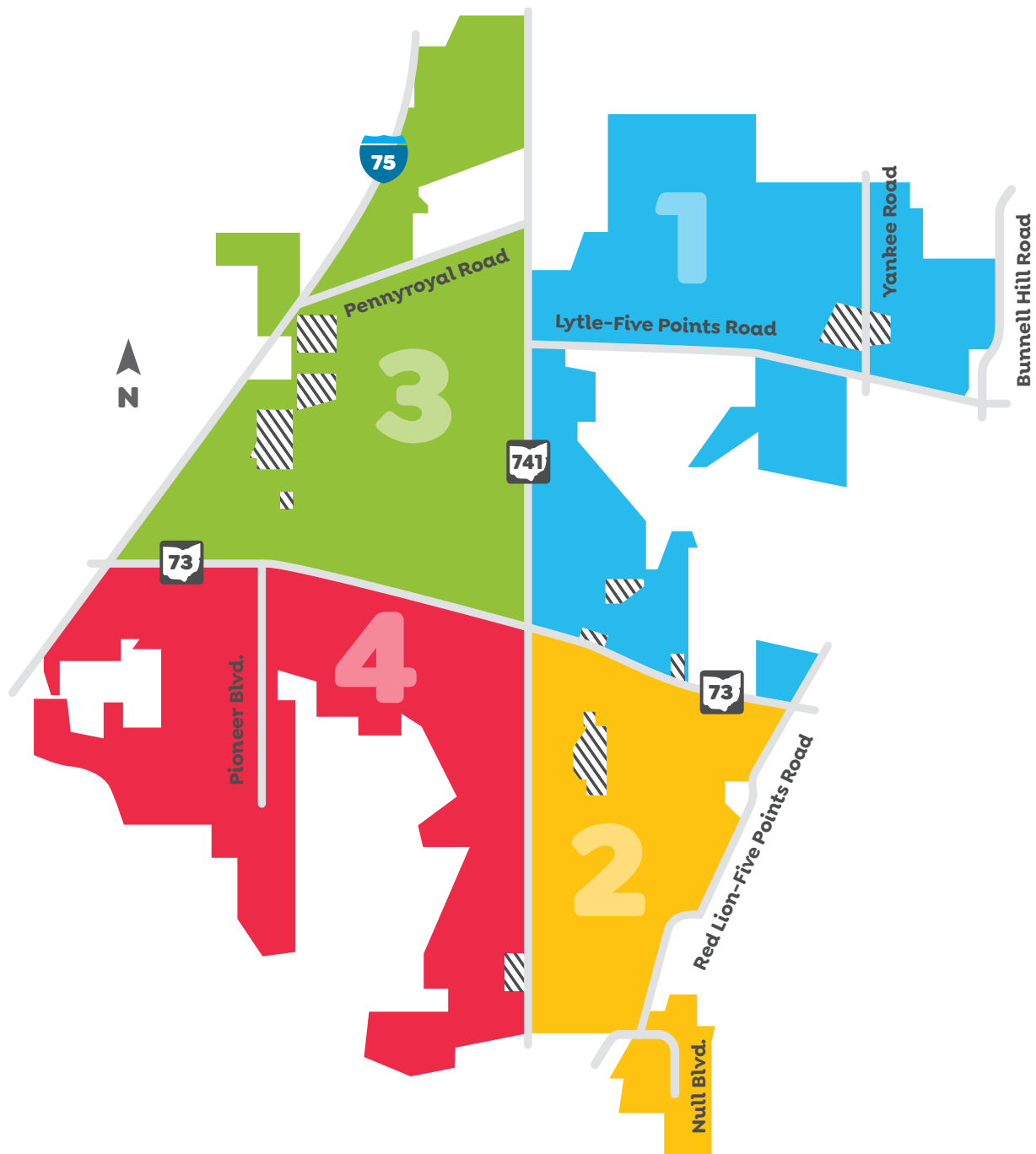


InnoMark Continues to Grow in Springboro

Right Turn Lane Under Construction at St. Rt. 741 and Remick Blvd.

An intersection improvement project on St. Rt. 741 and Remick Boulevard is underway. Under the sponsorship of the Warren County Transportation Improvement District (TID), contractors for the TID and the Ohio Department of Transportation will be constructing a right-turn lane on northbound St. Rt. 741 at Remick Boulevard in addition to installing a new signal and signal timing at the intersection.

The John R. Jurgensen Company was awarded a contract for approximately \$835,633 to complete the project, and all work is scheduled to be completed in the fall of 2024.

City Crews Ready for Snow

Springboro's Public Service Department is ready for winter! Our crews work to provide quality services so motorists can safely travel our roadways. So what is our process for clearing ice and snow?

1. Major arteries (St. Rt. 73, St. Rt. 741, Pennyroyal, Lytle-Five Points) are plowed first. We must keep roads clear for emergency vehicles, and conditions may require continued treatment.
2. Once major arteries are cleared, our crews move on to main streets and through subdivisions.
3. Residential streets, cul-de-sacs and courts will be serviced once the major arteries and main roads are cleared. Please help us by removing basketball hoops and parking your cars in the driveway. This allows the snow plows to better and more efficiently clean your streets so you can safely drive on them.

Check traffic before you go

Check out live road conditions and traffic situations 24/7 from the City website. The City has three live-streaming traffic cameras at the following intersections: St. Rt. 741 at Lytle-Five Points, St. Rt. 741 and St. Rt. 73, and St. Rt. 73 at Drug Mart. Interchange Makeover Project Underway



The I-75 and St. Rt. 73 intersection located in the City of Springboro and the City of Franklin is getting a makeover, thanks to an Ohio Department of Transportation Safety Grant and a partnership between the two cities, Warren County Transportation Improvement District (WCTID) and ODOT.

The Interchange Safety and Aesthetics Project will be completed in three phases, with the first phase—the start of the aesthetics—tree and shrub plantings outside of the work area for the safety project—already underway. Traffic patterns may change during construction. Please check our website and social media pages for updates. Following, the safety portion of the project will be started with the addition of turn lanes off the northbound exit ramp on St. Rt. 73 under the I-75 overpass as well as an additional turn lane on the I-75 northbound off ramp. After the safety improvements are complete, the remainder of the aesthetic improvements will be completed, including gateway enhancements. ODOT funded 100% of the safety portion of the project for about \$2 million. WCTID is managing the project.



Wright Station Park Area Sports New Look

The City's Wright Station central park upgrades are complete. Located at the intersection of St. Rts. 73 and 741, it has quickly become a popular spot for outdoor gatherings and concerts. New features include a stage area for entertainment, synthetic turf, paved walkways and a pergola along with additional seating, landscaping and new signage. The City was pleased to host 13 bands there July through early September.

Home to restaurants, retail and office spaces, a fifth building housing Tropical Smoothie Café and an office space has recently opened. Tres Amigos, located in the building to the north of the Performing Arts Center, is set to open soon.

City and Library Partner to Offer Next Destination Speaker Series

The City of Springboro Bicycle & Pedestrian Advisory Committee (BPAC) in partnership with the Franklin-Springboro Public Library will present the 2024 Next Destination Speaker Series focusing on hiking and bicycling programming. Pump It Up on New Bike Tracks

The new pump tracks at Community Park are complete. Located at the west end of the park, a rider on a BMX or mountain bike generates momentum by body movements instead of pushing or pedaling the circuit of rollers, banked turns and other features. The park features two tracks: a 810-foot track and a 200-foot all-accessible/youth track. Both areas will be completed using asphalt and connect to the park's restroom and shelters by concrete trail. The pump track was a recommendation of the Bicycle & Pedestrian Plan adopted by City Council in July 2020. The grand opening ceremony is Oct. 5, see BikingintheBoro.com for more information.

North Park Improvements to Begin Soon

Springboro's North Park is set to undergo a significant upgrade. The City is planning \$4 million in improvements and new equipment, including replacing the 25-year-old playground with two all-access playgrounds and pickleball courts. City Council approved the upgrades, which will take place over several years, using remaining COVID relief American Rescue Plan Act funds to cover much of the cost.

Phase I plans include a 30,000 sq. ft. all-access playground with two age-appropriate areas: one for youngsters under the age of five and the other for children 5 – 12 years of age. Elements include swings, slides, a zipline and climbing tower. In addition, musical play areas, similar to those found at the City's Kacie Jane Park, will be a part of the design.

Plans also include the addition of pickleball courts and upgrades to the areas near the amphitheater and concession building.

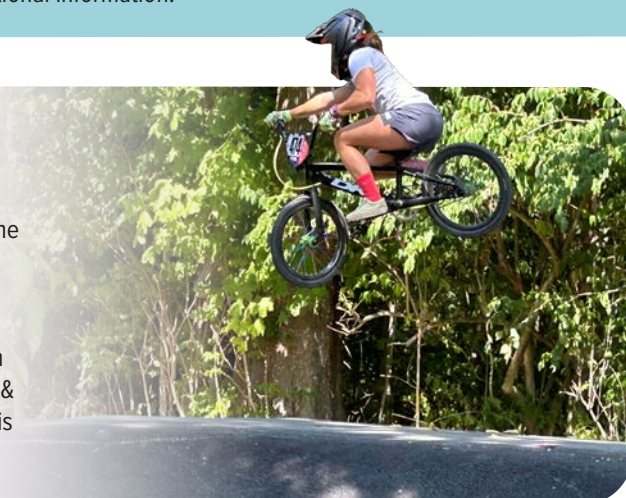
Located at 195 Tamarack Trail, North Park is Springboro's busiest park and home to the City's Summer Concert Series and other special events. Construction on the playground will begin in October with completion expected early next year.

Election Day

Tuesday, Nov. 7 is Election Day and polls are open 6:30 a.m. to 7:30 p.m. Three Springboro City Council seats will be on the ballot. Incumbent Mayor John Agenbroad and At-Large Council Members Stephen Harding and Becky Iverson are running unopposed in this election.

The ballot also includes one issue for Springboro voters—Issue 21—the continuation of the City's 0.5% income tax for the purposes of general municipal operations and capital improvements. The City's income tax rate has been the same since 1988 and voter approval of Issue 21 would keep the same rate until 2044. See more information about Issue 21 on page 3.

Drop Off Expired, Unused Pills at Drug Take Back Day

The Drug Enforcement Administration National Prescription Drug Take Back Day provides a safe, convenient and responsible means of disposing of prescription drugs.

Drop off expired, unwanted and unused pills and capsules **Saturday, Oct. 28** to the Springboro Police Department. Officers will be on-site 10 a.m. – 2 p.m. to collect prescription and over-the-counter medications. Pills should be removed from containers and placed in a zipper-lock storage bag for disposal. Liquids, creams, powders and needles are not accepted.

Following the event, representatives from the DEA will collect and safely dispose of the medications. In April, more than 65 lbs. of pills were collected from residents.

In addition to participating in the nationwide Take-Back events, the Police Department maintains a drug drop box located in the lobby of the City Building for drop-offs 7 a.m. to 11 p.m., seven days a week. For more information, contact Springboro Police, 937-748-0611.



Keep Your Vehicle Safe

Springboro residents are fortunate to live in a safe community, however, crime can occur anywhere. Your Springboro Police work to stay ahead of criminals each day and reduce one of the most common crimes in the City — thefts from motor vehicles.

Whether you are parked in a lot all day or just a few minutes, or in your own neighborhood, don't make it easy for thieves to break into your vehicle. Take steps to prevent thefts from vehicles and thefts of vehicles.

- Lock your vehicle: The majority of stolen vehicles are unlocked.
- Park in a well-lit, high traffic area whenever you are away from home.
- Take your valuables with you, if you can. If not, hide them in a secure area like the trunk.
- Call the Springboro Police immediately if you witness a crime or something suspicious.

- DO:**
- Carry a flashlight
 - Go in groups with at least one adult
 - Go to houses with the lights on
 - Make sure shoes fit and costumes are short enough to prevent tripping
 - Use common sense. If something feels wrong, it probably is
 - Dress for the weather. October brings cooler weather and sometimes windy and rainy conditions.

- DON'T:**
- Wear masks or any costume that would interfere with vision or walking
 - Go into a home of someone you do not know
 - Eat any candy or other items until it has been checked over by an adult

Most area communities have agreed to hold the event on Oct. 31 for the next several years.

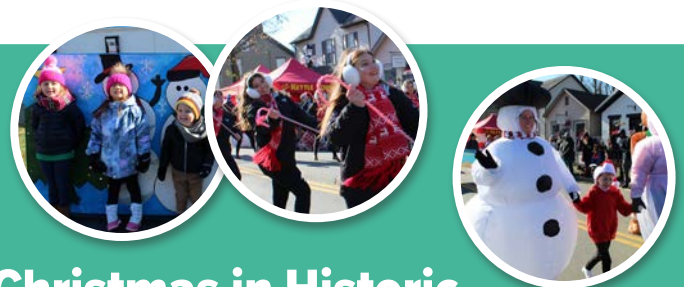
Historical Society Wraps Up Year with Programs and Special Events
