

Contest Description: The City of Springboro (“City”) Walking and Biking Wellness Program

How to enter: To enter the contest you must take a screen shot of the # of miles of walking or biking you have done within a specific month (May – September) on your walking or biking app or other electronic mileage device.

Who may enter: Any user of City of Springboro parks who is 18 years old or older. Individuals affiliated with the City, including employees, interns, volunteers, appointed and elected officials and their immediate families (children, parents, siblings and spouses) and others living in their households are not eligible for any prize. The City will determine winners’ eligibility in its sole discretion.

Term: The contest begins at 8:00 PM May 1, 2021, and ends September 30, 2021, at 5:00 PM Eastern Standard Time. By submitting an entry, each contestant agrees to the rules of the contest and states that he or she is 18 years old or older.

Winning: The City will randomly select 1 winner from each 20 entrants. If 1-20 people enter – 1 winner will be randomly chosen. If 21-40 people enter – 2 winners will be randomly chosen, if 41-60 people enter - 3 winners will be randomly chosen, and so on.

The City will notify winners via the contact information provided at the time of entry; the City may disqualify anyone who fails to respond to the notification within five business days.

Conditions of Entry: By voluntarily submitting a photograph on this website, you grant to the City (and those authorized by the City) an irrevocable, royalty-free, world-wide, perpetual, non-exclusive license to edit, alter, copy, exhibit, reproduce, create derivative works, and/or publish or distribute this photo (even when such photograph contains your likeness) in whole or part, in any media now existing or later developed for purposes of advertising, promoting or publicizing the City or its programs, events, and contests, or for any other lawful purpose.
