# FROM THE MAYOR AND CITY MANAGER



We are pleased to present the **City of Springboro's 2024 Annual Report**, showcasing the progress, achievements and financial stewardship of your local government over the past year. This report highlights how your tax dollars have been invested and outlines our budget and priorities for 2025.

As you review this report, we hope you take pride in the services, programs and amenities the City provided in 2024 and share in our excitement for what lies ahead in 2025.

## 2024 ACCOMPLISHMENTS

This past year brought significant advancements across our community, including:

- **New recreation amenities** – Installed the Dayton Children's Playground and six pickleball courts at North Park.
- **Enhanced city gateways** – Improved the I-75 interchange entrance, boosting Springboro's visual appeal.
- **Expanded internet access** – Advanced the **Fiber to Home** project, increasing service provider options for residents and businesses while introducing free public Wi-Fi at many City parks.
- **Trail system expansion** – Added two new multi-use trails connecting Clearcreek Park to Hazel Woods Park, as part of a broader effort to extend the network westward to Franklin.

Additionally, in partnership with Clearcreek Township, a **new fire station** is set to open this year, enhancing emergency response services for our community.

Springboro continues to earn recognition as one of **Ohio's safest cities**, according to SafeWise.com. We set a record with **25,000 attendees** at concerts and special events. Infrastructure improvements remained a top priority, with ongoing investments in street repairs. Meanwhile, our thriving local economy welcomed **25 new businesses**, and our financial management earned top marks, including a **clean annual financial audit**, the **Auditor of State Award with Distinction**, the **Certificate of Achievement for Excellence in Financial Reporting** and the **highest note rating of SP-1+ by S&P Global**.

## LOOKING AHEAD TO 2025

In the coming year, we remain committed to strengthening infrastructure and enhancing community amenities, including:

- **Street improvements** – Resurfacing **17 streets** and planning upgrades to the **N. Main Street and Lytle-Five Points intersection**.



- **Wastewater treatment upgrades** – Enhancing reliability with a **new generator** at our wastewater treatment plant.
- **Smart traffic technology** – Implementing **AI-driven traffic signal monitoring** to improve traffic flow and safety.
- **Trail development** – Constructing the **Community Park Multi-Use Trail**, an extension of the City's Central Greenway, with **80% of the project funded by state grants**.

## CITIZEN SATISFACTION & FISCAL RESPONSIBILITY

Every three years, the City conducts a **Citizen Satisfaction Survey** to evaluate community opinions on services, amenities and quality of life. In 2024, Miami University's Center for Public Management and Regional Affairs completed our sixth survey, with outstanding results:

- **95.5%** of residents rate Springboro as an **excellent or good place to live**.
- **More than half** of respondents believe the City has **improved over the past five years**.
- Satisfaction levels **increased in key areas**, including street maintenance, police services and park facilities.

Through strategic investments, **Springboro continues to offer exceptional amenities while maintaining one of the lowest income tax rates in the region and the third-lowest municipal property tax rate in Ohio**—a testament to our commitment to **fiscal responsibility** and **outstanding community services**.

## COMMITTED TO SPRINGBORO'S FUTURE

Your City Council and staff remain dedicated to making Springboro a premier place to live, work, and do business. By focusing on **resident satisfaction, safety, quality of life and financial stability**, we ensure that Springboro remains a top choice for families and businesses alike.

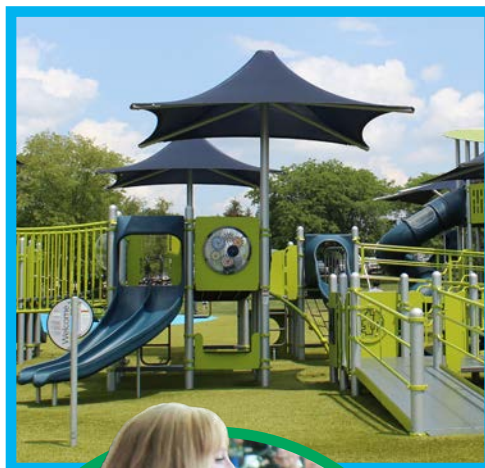

# 2024 FACTS, FIGURES AND HIGHLIGHTS

- Third largest city in Warren County, with a population of 19,475 (2022 Census)
- Lowest Municipal Property Tax Rate in the Miami Valley Region: 1.1 mils, and the third lowest municipal property tax rate in the State of Ohio

- Completed the safety upgrades project on State Route 73 at I-75 and intersection improvements on North Main Street at Remick Blvd. Construction costs for both projects were covered 100 percent by two ODOT Safety Grants totaling \$4.5 million. Upgrades included additional turn lanes to improve safety and traffic flow at these busy intersections.
- Celebrated the Total Eclipse event on April 8 at North Park with more than 4,000 in attendance
- Purchased 60 acres of Easton Farm to be used for open space and potential school building site
- Voters approved the ½ percent income tax renewal, helping to stabilize City finances and continue supporting capital improvements and operations that provide residents with a clean supply of water, safe, drivable streets, and well-maintained parks and neighborhoods. Thank you, voters!
- Saw record attendance of more than 25,000 for concerts at North Park and special events



- Opened the Dayton Children's Playground, 30,000 sq. ft. all-accessible play area
- Hosted Ohio Women's Open Championships at Heatherwoode
- Named a Community Resource Officer to the Police Department to bridge the gap between the community and the police department through events, education and programs
- Began installation of a new irrigation system at Heatherwoode Golf Club, replacing the original system installed at course construction in 1991. When completed in spring 2025, over 1,300 irrigation heads and more than 20 miles of HDPE pipe will be installed.
- Published our second PAFR: The Popular Annual Finance Report, City's financial report in an easy-to-understand format
- Started a Children's Movie Series at the PAC
- Offered Classical Music Series on Sunday evenings in June at North Park
- Hosted Mayor's Pastor Appreciation Luncheon
- Approved nine new business sites and four residential sites
- Participated in Geocache location with Warren County Convention and Visitors Bureau
- Gave away a theme-decorated Christmas tree via raffle for residents

Every three years, Miami University's Center for Public Management and Regional Affairs completes a Springboro citizen satisfaction survey. Key findings in the 2024 survey, our sixth, revealed more than half of the survey respondents think **Springboro has become a better place to live in the past five years with 95.5% reporting Springboro is an excellent or good place to live.** According to Miami University, Springboro has the highest satisfaction rates of any community they survey.

### PUBLIC SAFETY AND SECURITY

Springboro Police Officers continue to lead the way in law enforcement, apprehending several suspects in numerous burglaries and other crimes from across the region. The Police Division remains vigilant to keep our community safe.

Notable staff and department achievements:

- **Officer Heath Martin** received The Carnegie Medal from the Carnegie Foundation, the Robert B. Jacob Award of Merit, and the Kaia Grant Badge of Bravery and Sacrifice award from the Ohio Secretary of State for his heroics in safely removing a man from a burning house
- **Officer Carl Hoskins** received the regional TCSU (Tactical Crime and Suppression Unit) Investigator of the Year Award
- **Officer Antwaun Scott** received a Lifesaving Commendation Award
- **Officer Carl Hoskins** received a Letter of Commendation
- **Sgt. Drew Pyles** graduated from Police Executive Leadership College
- **Sgt. Bill Clevenger** became the department's first licensed UAS operator
- **Officer Aaron Morgan** served in newly created Community Resource Officer position
- **Officer Blue** won the Light Ohio Blue Fur-Responder Challenge



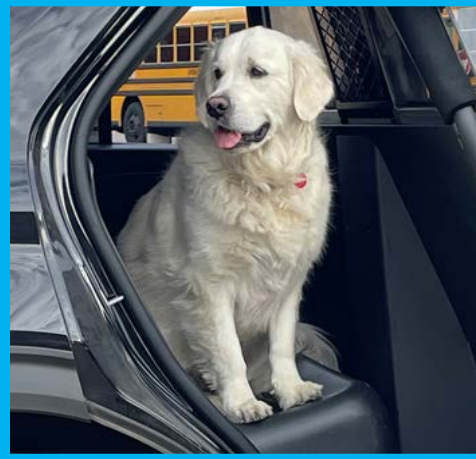
This is the second project through our partnership with WCCC. Students designed and installed vinyl wraps on two Springboro traffic control boxes. The wrap at St. Rts. 73 and 741, near the Performing Arts Center, highlights the arts, while the one at Lytle Five Points and St. Rt. 741 showcases popular amenities like Kacie Jane Park's splash pad, biking, the Veterans Memorial and the Dayton Children's Hospital Playground.

- Announced the development of the **Vietnam Veterans Remembrance Memorial at Gardner Park**. The memorial will serve as a tribute to the Ohio soldiers who sacrificed their lives during the war and the names of the Vietnamese citizens who perished in the re-education camps. The project will be funded through private donations.

## BICYCLE AND PEDESTRIAN PROJECTS

- Welcomed **19,600 individuals** including walkers and bikers passing the trail counter at E. Milo Beck Park
- **Awarded \$720,200** in funding to construct a multiuse trail through the west end of Community Park and crossing Twin Creek. Construction to begin in 2028
- Celebrated the **11th Bike the Boro** at North Park with 178 riders
- **Earned Bicycle Friendly Community Bronze award** from the League of American Bicyclists, one of only 19 communities in Ohio to achieve that status
  - Maintained more than **12 miles of bike paths and trails**

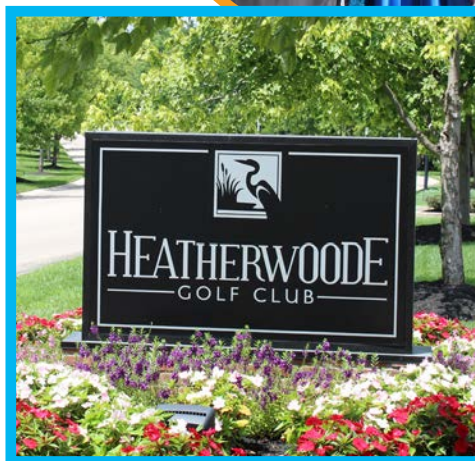

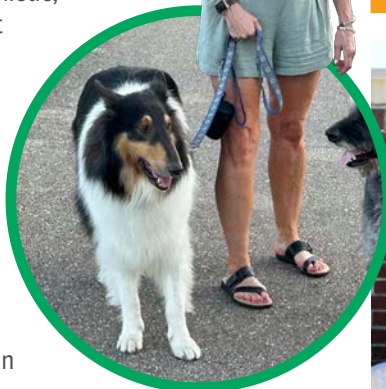

## SMART CITY INITIATIVE/ TECHNOLOGY UPGRADES

- **Fiber to Home project:** As part of the City's Fiber Master Plan, in partnership with the Warren County Port Authority, invested \$2.4 million to build a 17-mile broadband fiber network to provide high-speed internet service. The fiber network has attracted two Internet Service Providers (ISPs), giving Springboro residents a variety of options and places us in the 0.3% of communities in the US offering three or more high speed fiber providers to every residence.
- **Installed free public Wi-Fi** in Historic Downtown Springboro, Wright Station, the City Building/Library parking lot and North Park. More parks are set for Wi-Fi in 2025

## PRESERVING OUR HISTORY

- Recognized **South Dayton Church of Christ** for the preservation and restoration of the upper portion of the belltower for the Old Stone Church, 300 S. Main St.
- **Approved 19 restoration projects in the Downtown Historic District** and stand-alone landmarks through the Architectural Review Board for investment in this federally protected district



- **Resurfaced 22 streets (5.49 miles)** including curb, sidewalk and driveway apron repairs, the Street paving budget has doubled since 2014
- **Replaced** approximately 1,900 linear feet of 8" diameter **water main**



- Offered **water and sewer payment reduction program** to senior citizens
- **Streamlined utilities payments** by offering online payments and notices

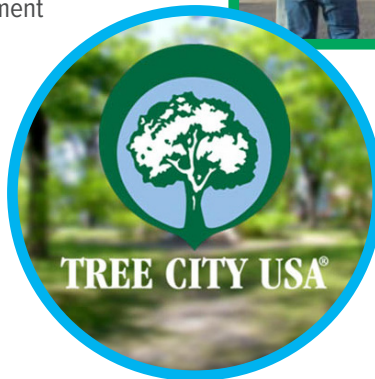

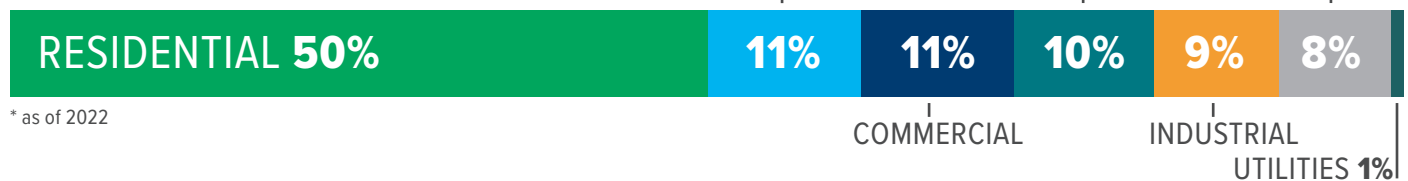

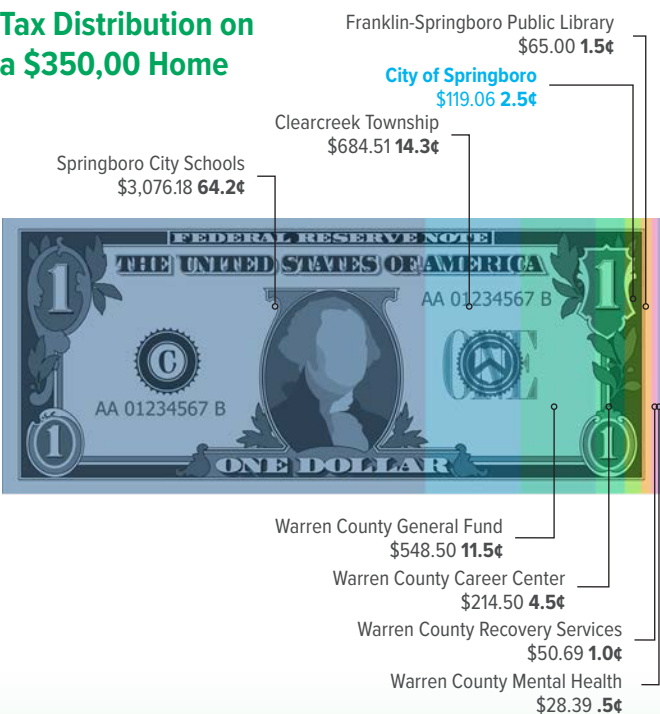

The 2025 Budget is built upon **conservative budgeting** principles and structured to provide **efficient and quality resident-focused services**. The budget reflects an emphasis on **delivering core services, maintaining city infrastructure and providing safe and reliable public utilities**. Key investment areas include **public safety, community grants, recreation upgrades, community events and public utility improvements**. Sufficient funds have been allocated to ensure the City can provide the quality services that make Springboro the **best place to live in Ohio**.

Tax Distribution on a \$350,00 Home



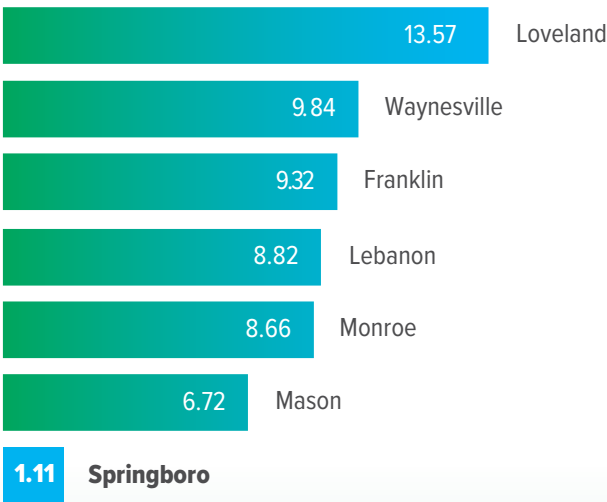
Property Taxes

Our municipal property tax rate—at 1.11 mills—is the lowest in the region. 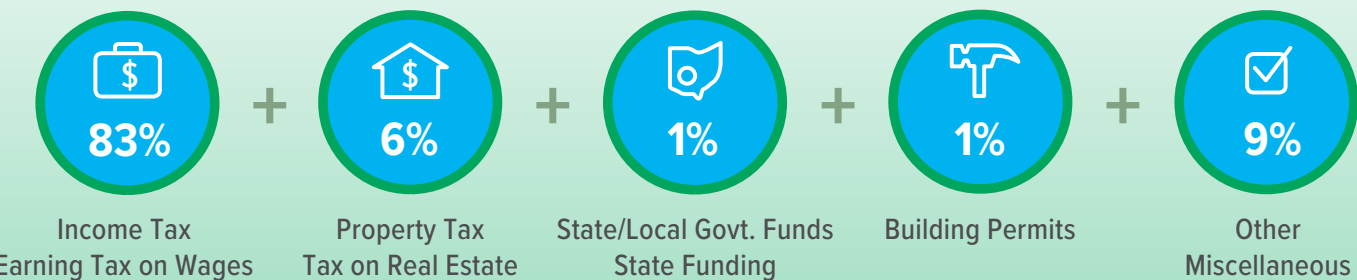
Understanding Property Taxes

Property tax is based on the amount charged per \$1,000 worth of taxable property value, also known as “millage.” Amounts collected for levies, other than general operating levies, must be used for those specific purposes. The County Treasurer’s office collects property taxes and the County Auditor’s office distributes those taxes to the appropriate jurisdiction.

## City relying more on income tax, Springboro property tax rate is lowest in region

### Income Taxes

Income tax is the largest single source of revenue for the City. Generated from employee withholdings, taxes on the earnings of Springboro businesses and taxes paid by individuals—income tax comprises 83% of the General Fund. As Columbus continues to cut funding to cities, Springboro has increased its reliance on local income tax revenue.

**The City of Springboro's income tax rate of 1.5% has been in place since 1988.** The chart shows how Springboro compares to other cities in the region.

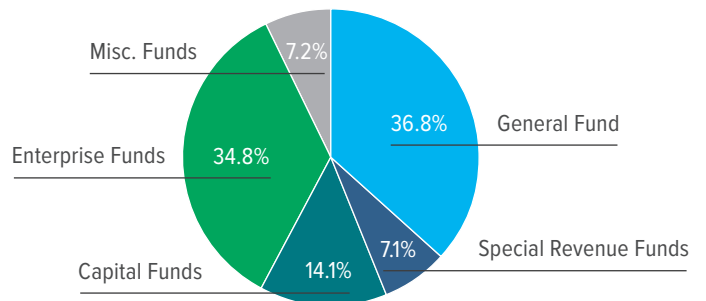

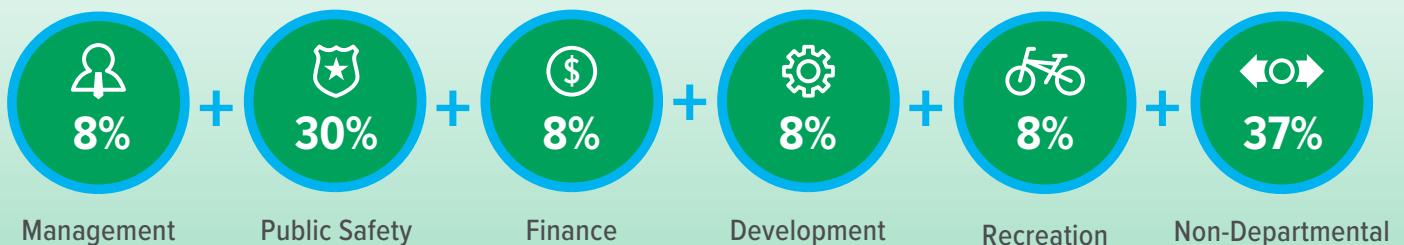
